- 6. Electronic bids must be submitted through PPMO's e-GP system www. bolpatra. gov.np/egp on or before 26-01-2024 12:00. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 26-01-2024 14:00 hours at the office of Aamachhodingmo Rural Municipality, Goljungbensi, Rasuwa Bagmati Province Nepal.
- 8. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 3400000 which shall be valid for 30 days beyond the validity period of the bid.
